2012 North Shore Country Day School Summer Programs Policies

Registration Policies A completed application for each camper with full deposit is necessary to process a camper's registration.

DEPOSITS \$500 per child is required with registration for the Day Camp, Expedition Camps and Language Immersion Program. This includes a \$200 non-refundable and non-transferable application fee. The remaining \$300 is refundable until February 29, 2012.

DISCOUNTS Family Discount \$50 off tuition balance for each child after the first camper enrolled in camp.

Early Discount \$50 off tuition balance for each camper enrolled before December 16, 2011.

BALANCE OF TUITION Families will be issued two billing statements. The first installment – for half the tuition less deposit – will be mailed January 31, 2012, and is due by February 29, 2012. The final statement will be mailed April 2, 2012, with the balance of fees due on or before April 30, 2012. **North Shore Country Day School reserves the right to cancel enrollment if fees are not paid by the above dates.** For registrations received after January 31, 2012, the tuition will be billed in full.

REFUND POLICY If a cancellation occurs prior to February 29, 2012, the deposit – less \$200 application fee – is refundable. Deposits are non-refundable and non-transferable after February 29, 2012. After June 22, 2012, there will be no tuition refund in the event of a withdrawal from any summer program. Partial tuition may be refunded if written cancellation is received prior to June 22, 2012. Phone cancellations are not accepted.

Space is limited; therefore, registration will be on a first-come, first-served basis.

North Shore Country Day School and the Summer Programs reserve the right to cancel any program if unforeseen circumstances occur. All money will be refunded on a prorated basis.

While North Shore Country Day Summer Programs will make every attempt to accommodate all children, the Summer Programs will not accept children who are (1) a danger to themselves, (2) a danger to others, or (3) a disruption to the normal activities making it unreasonably difficult for other children to enjoy summer programs. Additionally, any of the above reasons will be grounds for dismissal from camp. A parent/ guardian is strongly urged to discuss with the director any special conditions or circumstances involving his/her child prior to registration.

In compliance with the North Shore Country Day School policies, all information requested on your child's health form must be completed before your child can attend camp. Health forms must be returned by May 15, 2012 which allows for full processing and maintenance of accurate records.

Neither North Shore Country Day School nor the Summer Programs provide accident insurance for campers.

By signing this application, you grant North Shore Country Day School and the Summer Programs the right to use pictures and any other form of media including images of your child involved in activities in Summer Programs or North Shore Country Day School publications and marketing materials.

Parents are urged to mark all clothing, towels, etc. with nametags to insure complete identification of all items.

Participants are discouraged from bringing unnecessary personal items, and, in particular, anything of value such as jewelry or large amounts of money. No personal radios or electronic games are allowed on the campus during program times. Neither North Shore Country Day School nor the Summer Programs is responsible for lost or stolen items.

I consent to my child's participation in the Summer Programs. I further consent for my child to leave the North Shore Country Day School site to participate in authorized Summer Programs trips and to ride in authorized vehicles for the purpose of transportation in connection with the Summer Programs. I acknowledge that participation in the Summer Programs includes inherent risks. I expressly assume the risk for any and all injuries (including death), illnesses, damage or loss which may result from my child's participation in Summer Programs activities. I hereby voluntarily release and discharge North Shore Country Day School, its agents and employees from any and all claims for injury, illness, damage or loss which my child may suffer as a result of his/her participation in the Summer Programs, other than by injury, illness, damage or loss which arises from the gross negligence or willful and wanton misconduct of any agent or employee of the North Shore Country Day School.
